TERMS:

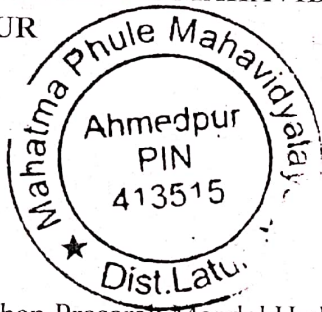

This agreement may be extended by mutual Consent of two parties after the period of Five (05) years, and it must renewed in written. This memorandum of understanding Completed is hereby signed in two (2) copies with one (01) copy remaining in the possession of each institution.


